September 5, 2017, San Diego — The United States Patent and Trademark Office (USPTO) has issued Ameranth a new **Poker/Gaming** patent, # **9,754,446** titled: 'Products and Processes for Operations Management of Casino, Leisure, and Hospitality,' which will have a term extending until at least 2025.

This new patent is the **seventh** in its family of poker room/casino patents) licensed by the three largest poker rooms in the world. This new patent further protects Ameranth's revolutionary automated poker room and casino management inventions and supports Ameranth's long term strategic relationship with **Genesis Gaming Inc.** It provides even more protection for the **Bravo™ Poker** family of products including its new **Bravo™ Cage** Application and for its industry leading, 'online tournament registration' – (OTR) functionality now approved to enable online poker tournament registrations for the **World Series of Poker (WSOP)** (the world's largest and most respected poker tournament.) Additionally, this new patent includes **#12** comprehensive patent claims for player tracking at/from the table and including all technology based player cards, as well as smart phone based solutions for mobile player registrations.

These comprehensive new patent claims include not only the operation of large and small poker rooms throughout the US, but also online tournament registrations for those poker rooms and integration with card based player tracking systems as well as many key poker tournament features, reflecting the visionary aspects of Ameranth's family of gaming/poker patents. This patent was allowed, even under the increasing scrutiny resulting from recent US Supreme Court rulings, which have generally made software based patents more difficult to obtain; thus making this patent extremely important and further confirming the numerous technological breakthroughs in Ameranth's gaming/poker patents as being truly novel.

This 7th patent – # **9,754,446** along with Ameranth's existing gaming/poker patents i.e. (U.S. Pat Nos. **9,005,031; 8,393,969; 7,878,909, and 7,431,650, 9,072,965, 9,390,590**) further protects Ameranth's innovations for current and emerging automated casino and poker room applications and deployments. The totality of these seven patents, with more than **#160** claims between them, provides an extensively broad and valuable gaming/poker patent portfolio.
